Be Free In God Board Annual Compliance

The following questions relate to the board of directors for organizations who have filed Articles of Incorporation and are incorporated at the state level.

Board Orientation and Education

Does the board conduct a formal orientation for new board members and require all board members to sign a written agreement about their roles, responsibilities, and expectations? **Yes.** See [The People Behind What We Do](#) sections above.

Without clarity around responsibilities and expectations, board members are not positioned to succeed. They may find themselves challenged to fulfill their governance responsibilities or frustrated by the expectations that the organization has set for them. BoardSource recommends that every new board member take part in a formal orientation process, and that all board members sign a pledge or agreement committing to their board service and to all the responsibilities and expectations coming with service. Ideally, board members also should take part in a formal governance training program prior to serving on a board.

Be Free In God Oversight

Has the board conducted a formal, written assessment of the COB within the past year? **Yes.**

Oversight and management of the Chairman of the Board (COB) is one of the Board's most important legal responsibilities. Regular and written assessment is critical to ensure the COB and Board are communicating openly about goals and performance. BoardSource recommends boards conduct formal, written reviews of their chief executives on an annual basis, which should include an in-person discussion with the chief executive and distribution of the written evaluation to the full board.

The Board elects Sean Patrick as COB.

Be Free In God Ethics and Transparency

Have the board and senior staff reviewed the conflict-of-interest policy and completed and signed disclosure statements within the past year? **Yes.**

A commitment to oversee conflicts of interest is essential to creating an organizational culture of transparency. Boards should create and follow a policy for finding and handling conflicts of interest, whether real or perceived. BoardSource recommends organizations review the conflict-of-interest statement and require signed disclosures from all board members and senior staff on an annual basis.

BoardSource recommends boards commit to diversity and inclusion by setting up written policies and practices, which include strategic and intentional recruitment of diverse board members, continual commitment to inclusivity, and equal access to board leadership opportunities.
